Discussion and action on CentralSquare Phone conversion to Cloud

Raymond presented quote paperwork from CentralSquare in the amount of \$79,787.77 to move the phone system to Cloud. The first required payment will not be due until after 12/01/2026 which is the fy27 fiscal year. Cost increases for the next 5 years would be zero percent for Years 1 and 2 then 3% for 3-5. Then Year 6 it would resume back to the 5% cost accelerator.
